



## DOWNTOWN ALIVE MAC ARTS TENT 2019 - APPLICATION

The City of Greenville and the Metropolitan Arts Council join forces to offer a special opportunity for Greenville's local artists and arts organizations.

Since 1987, Downtown Alive has provided a steady and significant stream of income for MAC. Now in its 4th decade, an estimated 45,000+ people will gather on North Main Street in front of the Hyatt Regency to enjoy live music and libations every Thursday from March 21 through August 29. To highlight the visual and performing arts, each week the city sets up the DTA-Metropolitan Arts Council tent.

Each week MAC invites two constituents, preferably an individual artist and an arts organization, to share the space in the tent to display work, sell tickets, offer promotional materials or anything that takes advantage of this free and unique marketing opportunity.

With the 10' x 10' tent, the city provides three 6-foot tables and two chairs. Display panels and easels are the responsibility of the artist but all display items must fit within the tent space. Artists and arts organizations may sell art, performance tickets and pre-approved promotional items during the event but the sale of food or beverages sales is strictly prohibited. Electricity and wireless service will be available.

Downtown Alive runs from 5:30pm until 8:30pm Thursday evenings from March 21 through August 29, 2019. Tent set-up must be done between 4:00pm and 5:00pm. Vehicles are allowed on-site to unload only and must be moved and reparked until after official Downtown Alive closing time (8:30pm).



Artists and arts organizations must be Greenville County based. Tent assignments will be selected on a first-come, first-serve basis. The accompanying application must be filled out and submitted to MAC either by mail or in person. Artists new to Downtown Alive must provide a digital portfolio of work, 3-5 images (unless a previous portfolio is on file with MAC for Open Studios, Flat Out Under Pressure, or MAC's online artist directory).

There is no deadline for the application. If you have been selected to participate, a one-week notice is required if you are unable to attend a committed Thursday evening.
